#### Introduction

This Community Wildfire Protection Plan (CWPP) was developed by Real East County Fire Safe Council with guidance and support from the County of San Diego, California Department of Forestry and Fire Protection, the United States Forest Service, and the Bureau of Land Management. This CWPP supplements San Diego County Department of Planning and Development Services documents referenced in Appendix A.

The Real East County Fire Safe Council includes:

The communities of Jacumba, Boulevard, La Posta, Lake Morena and Campo along Highways 94 and 80, served by one common fire safe council.

The Real East County FSC communities are located just north of the international border in Southeast San Diego County. With Pine Valley and Potrero to the West, the council extends to the easternmost boundary of San Diego County. These areas together cover nearly 150 square miles, housing over 3,500 people in nearly 2,500 housing units.

**Community Overview** – Description of topography, population, climate, land uses, businesses, schools infrastructure, fire safe councils, and other applicable traits specific to this CWPP area.

The communities that comprise the Real East County Fire Safe Council are similar in geography. The elevation ranges from approximately 2,500 feet to over 4,000 feet in a pattern of north-south trending mountain ranges and valleys. The primary route transecting the area is Interstate 8, a four-lane highway. Via I-8, San Diego is approximately 60 miles west. El Centro lays approximately 50 miles to the east. The council includes the communities of Jacumba Hot Springs, Boulevard, La Posta, Campo, and Lake Morena.

The communities have similar vegetation types and topographical features. The region is characterized by steep slopes, rocky terrain, deep canyons, and high hills with large swaths of wildlands between homes and communities. Vegetation is a mosaic of predominantly chaparral shrubs including: Chamise, Ceanothus, Manzanita, Buckwheat, Sage scrub, along with grasslands. Riparian systems line several of the valley floors. Some oak woodlands are interspersed throughout the region. The vegetation class is predominantly chaparral with oak woodlands.

The vegetation in highland valleys range from grassy meadows to riparian woodlands in seasonal watercourses. Scattered oak woodlands are also present. Mountain slopes exhibit sparse to heavily dense scrubland consisting of Mixed Chaparral, Manzanita, Chemise, Red Shank, and others.

Fire and Emergency Medical Services are provided by, San Diego County Fire and CAL FIRE. The communities are within the Real East County Fire Safe Council area of influence and considered Wildland Urban Interface (WUI) areas. Public lands adjacent to or within these areas include the USFS Cleveland National Forest, Bureau of Land Management and State Responsibility Areas. Within the FSCs area are properties owned by the City of San Diego including Lake Morena. There are a number of natural preserves in these communities. The Dulzura / Barrett areas have seen greater than average fire return intervals, essentially making them high risk areas.

Two Military training facilities are located in and around the area of Campo and Lake Morena.

Three major US Border Patrol facilities and base of operations centers are located within the council's area. There is a US Border Patrol border checkpoint.

Homes and other structures are scattered throughout the region. All homes are individually built. There are some historical homes in the communities, some 100 or more years old.

Jacumba, Boulevard, Campo, Lake Morena have U.S. Post Offices, a grocery store, a Community Center, diners and café and some smaller local businesses.

Boutique wineries are a growing cottage industry in the area. A majority of lands is agriculture and ranch lands.

Winds are common with the dry strong north and east winds (Santa Ana Winds) the deadliest in relation to fire. These predominate land features combine with the weather to create a corridor of extreme fire potential. The usual winds are from the west and south, which also can be a problem as they can be strong at times.

Although the area is not densely populated, there are a few areas of fairly dense clusters of housing that are highly vulnerable to fire, including; Lake Morena Village, Campo Hills, Tierra del Sol Heights, central Boulevard areas.

Major water storage can be found at Lake Morena (400-700 acres or an estimated 1.9 billion gallons) There as some seasonal ponds in the area. These provide the area with a potential water supply for firefighting particularly helicopters. There are limited fire water Storage tanks for firefighting. Frequent power outages both planned and unplanned during high wind events highlight the need for improving water storage in these communities.

Also, there is the danger posed by possible terrorist events in San Diego. A significant event could cause power outage, disease, and a mass influx of people to this area in need of shelter and support.

The proximity of the U.S.-Mexico border creates its own difficulties, as fires starting in one country sometimes spread to the other. Cooperative fire efforts are encouraged via planning and communications. Frequent threats from fires originating in Mexico is a major consideration for fire safety planning.

Three primary roads, Highway 94, Highway 80 and Interstate 8, which runs east/west is the only major roads through the communities. These primary traffic route can, and has been, blocked by natural problems, flooding, boulders, and/or fire. These communities are very easily isolated, highlighting the need for community preparedness.

The limited extent of passable dirt roads and one sole egress route causes difficulty in emergency evacuations.

#### Eire History

Recent fires include: 2017 Eclipse Fire and Church Fire, 2016 Border Fire, 2015 Corners Fire, 2011 Lake Morena Fire, and of course, the 2007 Wildfires, 2003 Cedar Fire Annual fires near or on the US/ Mexico border are a common occurrence. #### C. Identification of Community Values at Risk

Using technology and local expertise, the sponsors of this CWPP have developed a series of maps depicting the site and situation of the *Jacumba Hot Springs*, *Boulevard*, *Campo*, *La Posta*, *Lake Morena* Communities. (Appendix B).

#### Values at risk within the community are:

The following places are named for their aesthetic, intrinsic or safety value to each community:

**Jacumba Hot Springs** - Desert View Tower, Hot Springs Spa, Highland Community Center, Airport, Lake, Library, school and Post Office, Jacumba HS Community Service District (water), SDG&E Power Outage Resource Center.

**Boulevard** – Border Patrol Substation, Sheriff's Station, Live Oak Springs Resort, Library Kiosk, schools and Post Office, Backcountry Resource Center, SD Astronomy Association, McCain Valley CAL FIRE Honor Camp, Lark Canyon Recreation area (BLM), Rough Acres Conf Center, Live Oaks Springs Water District.

Campo - Gaskill Stone Store, Pacific Railway Museum, Golden Acorn Casinos, Mountain Health Clinic, Campo Community Center, CLEEF, Camp Lockett Historical area, Motor Transport Museum, Freedom Ranch, Southern Indian Health clinic, SDG&E Power Outage Resource Center.

La Posta - US Border Patrol Facilities, US Navy Training Facility at La Posta, Substance Abuse Center.

Lake Morena – US Navy site at Camp Morena, Lake Morena County Park, Lake Morena Views Water District, Lake Morena Oak Shores Mutual Water District, LM Repeater Site, SDG&E Power Outage Resource Center.

For communities within the Real East County FSC, values at risk within the communities are:

- · Homes, primary residences for the community along with associated personal storage and vehicles.
- Local businesses, markets, café, feed stores.
- Local faith-based facilities and services.
- Winery businesses, agriculture fields, and livestock areas.
- Local infrastructure, such as Highway 94 and 80, and areas east to the eastern edge of the county.
- Fire Stations with full time personnel and fire engines.
- Native cultural sites. Historical seasonal homelands.
- · Local habitats, such as Live Oak woodlands.
- · Sensitive species such as snake cholla and others.
- Mixed Chaparral and Sage Scrub habitat that host sensitive local flora and fauna.
- · Watershed function: public and private water system integrity and local aquifers.
- \* Aesthetics: Preserves, Open space lands and agricultural trusts, Wildlife refuge, views capes, etc.

For communities within the Real East County FSC, some specialized and challenging firefighting hazards associated with the below energy corridor related projects must be considered. In many cases, incidents starting here may not be directly attacked near the fire start location. In most cases, fire suppression will not be initiated for some distance due to the electrical or debris hazard presented by towers, turbines, panels, or transformers. These specialized values at risk within the communities are:

D. Local Preparedness and Firefighting Capability— All fire jurisdictions within the area as identified by this CWPP are listed below with information as available on number of firefighting personnel and fire response vehicles:

Fire protection for the Real East County FSC CWPP region is provided by CAL FIRE along with San Diego County Fire. The Fire Safe Council area includes the communities of Jacumba Hot Springs, Boulevard, La Posta, Campo and Lake Morena. They provide the primary dedicated fire protection and EMS services. One IoCAL FIRE station is staffed full time for each community, the CAL FIRE/SDCo Fire Stations as noted below. US Forest Service / CAL FIRE is the primary wildland and federal properties provider in the area along the I-8, Highway 80 and 94 corridors.

A specialized Foam Trailer for use in Alcohol Resistant fire needs is also available in Lake Morena.

Along with the volunteers of this active Fire Safe Council, there are Community Emergency Response Team (CERT) members active locally. Organized Ham Radio volunteers, Red Cross and Animal Services volunteers within the communities served by the Real East County Fire Safe Council.

#### SECTION II: PRIORITIZED FUEL REDUCTION TREATMENTS

The partnership that exists between the listed organizations and citizens in this CWPP allows the communities of Boulevard, Campo, Jacumba Hot Springs, La Posta, and Lake Morena -to reduce hazardous vegetative fuels that could ignite residences and commercial facilities, particularly, during Santa Ana wind fire conditions. Maintaining properties with the appropriate defensible space is a key factor to protecting lives and properties.

The CWPP is not to be construed as indicative of project "activity" as defined under the "Community Guide to the California Environmental Quality Act, Chapter Three, Projects Subject to CEQA." Any actual project activities undertaken that meet this definition of project activity and are undertaken by the CWPP participants or agencies listed shall meet with local, state and federal environmental compliance requirements.

#### A. Priorities

#### Regional & Local Projects. The Real East County Safe Council supports:

- Chipping for fuel reduction and abatement to meet SD County fire standards.
- Assist with 100' defensible space around structures.
- Roadside vegetation management along roads.
- · Removal or treatment of dead and diseased trees.
- Wood splitting as part of fuels management, local firewood use only (containment of potentially contaminated wood.
- Develop program to educate residents about defensible space and natural fire resistive vegetation concepts.
- Research and identify resources for maintaining defensible space and vegetation reduction.
- Assist seniors and disabled in creating defensible space (including clearance around service drops).
- Perform hazardous brush abatement around homes reservoirs, tanks, pump stations and distribution facilities.
- Pursuit of bio-waste and or vegetation reduction transfer stations in East County, Campo.
- Continuing our program to educate our residents on Sempra Energy "Sunrise Power Link" grant programs including structure hardening, defensible space improvements and fire safety items.
- · Community education for fire danger awareness and limitations.
- Installation and maintenance of emergency water supply firefighting storage tanks.
- Continued partnership with SD County Community Center for Fire Safe Council education programs and meetings.
- Structure hardening or home pre-treatments such as wet waters foams and gels.
- Power Grid improvements and strengthening to reduce the fire threat.

#### Community Specific:

- Fuel breaks Tierra Del Sol project, Powerline associated fuel breaks, International border fuel breaks, fuel breaks in and around protected habitat throughout Real East County areas in cooperation with BLM, CDFW, CAL FIRE and USFS.
- Fuel breaks. Develop fuel breaks, Improve clearances and for escape.

- Encourage SD County Graded road improvements all private dirt roads, to assist in emergency evacuations.
- Maintain roadside vegetation along primary escape routes, alternates and contingency roads.
- Maintain normal annual clearing within the community and past projects.
- Active weed abatement program support for loCAL FIRE agencies.
- Active Defensible Space Inspections, DSI support for IoCAL FIRE agencies.

- Working with CAL FIRE and BLM on the International fuel break, including over Border Fuel Breaks.
- Hazardous vegetation removal Letter of Authorization (where 100' defensible space includes BLM land).
- Ongoing Utility safety programs provided by contractors for SDG&E, AT&T and Cable providers.
- Normal Annual Clearing and active weed abatement programs.
- Annual Defensible Space Inspection (DSI) from loCAL FIRE agency.
- Community Clean-Ups to reduce yard hazards for fire crews.
- · Tire removal program.
- Hazardous Waste removal program in support of SDCo programs.

#### C. Gollaborative Projects

- Calexico Lodge Cleanup- Remove large piles of cut organic matter. Dumpsters will be provided, and volunteers will provide labor to fill the containers.
- Jacumba Lake Cleanup -Allow for refilling of helicopter water apparatus by restoring safe access to the Lake. Overgrown vegetation will be removed or thinned.
- Lake Morena USFS Fire Break-Establish new fire breaks on Forest Service Land around Lake Morena Village.
- CALFIRE Corte Madera Vegetation Management Project Multipart project consisting of restoring firebreaks and major fuel reduction activities on Corte Madera Ranch.
- Border Fence/ Border Roads Border Patrol Maintains a 60' corridor along the border.
   Many roads used by the Border Patrol are well maintained, there is minimal intrusion of vegetation into the roadway.
- County DPW & CAL TRANS maintain roads and Right-of-ways under their jurisdiction. Those
  agencies are charged with maintaining a safe road condition.
- Pacific Imperial Railroad Company operates the section of rail which bisects the CWPP boundary.
   PIRC states they have begun upgrades to make the line functional. PIRC is responsible for improving condition and maintenance of vegetation in the railway corridors.

Invasive species, specialized education and treatment for expanding problem in the area. These include mistletoe, dodders, etc.

Support a study on the changes of climate and its future fuel changes to our area.

Support improved dialog with neighboring reservations and tribal lands managers.

Support a study on the impact to improving cell phone coverage lost due to wind turbines and Mexican Prison.

Encourage burn where you buy wood use program.

#### SECTION III: TREATMENT OF STRUCTURAL IGNITABILITY

In cooperation with the County of San Diego, the *Real East County CWPP* supports and promotes fire safe activities and supports and educates its citizens in ways to reduce structure ignitibility through meeting the requirements of the County of San Diego Building and Fire Code.

Following is a description of structural challenges, including proposed methods of improvement and implementation proposed for the community:

The partnership that exists between the listed organizations (federal, state, and local) allows the Real East County Fire Safe Council to reduce hazardous vegetative fuels that could ignite residences and commercial facilities during wildfires.

- Encourage and retrofit homes to meet current and improved structure hardening standards.
- Encourage natural fire resistive vegetation to reduce ignitability of homes.
- · Community education in reducing structural ignitability
- This material and education may be provided in both English and Spanish
- Standardize addresses, street names and use non-combustible signage with reflective lettering; include color-coded signage indicating water availability
- Obtain community water tank(s) and necessary hardware supply for fire suppression.
- Create fire gel cache and appropriate equipment for application. Make available for purchase on a sliding scale. Cooperate with IoCAL FIRE agencies to determine proper/effective usage and inform users.
- Encourage water tanks for firefighting to current fire codes. Reduce fuels around tanks; allow adequate
  defensible space, visibility and accessibility for fire crews. Have 4" male national hose (NH) adapter and
  4" to 2.5" national hose (NH) reducer.
